PELICAN SUMMER FUN GUIDELINES AND DISCIPLINE POLICY

Our goal is to provide children and staff with a Summer Fun experience that is safe and enjoyable. To help us accomplish this goal the following guidelines have been developed. All children must understand and follow the guidelines set forth.

Please review these with your child.

- Summer Fun participants are expected to exhibit appropriate behavior at all times.
- Talk in a pleasant manner. Foul language and bullying will not be tolerated.
- Be safe! Always obey rules and staff.
- Treat all equipment and supplies with proper care and respect.
- Show respect for the staff, bus driver, and friends.
- Running and excessive shouting while in indoors is not allowed.
- Aggressive behavior that is threatening to the child, staff or others will not be permitted.

A caring and positive approach will be taken regarding discipline. Staff will reinforce appropriate behavior through positive reinforcement, firm statements, and redirection of activity. Listed below are the discipline procedures for children who are exhibiting unacceptable behavior. Depending on the severity of the behavior, we may skip a particular step. (i.e. aggressive behavior will not be tolerated)

STEP 1—Verbal Warning

STEP 2—Time out or time away from the group. During a time out, a child may have to sit out from activities. Parents will be notified of their child's time out.

STEP 3- If a child persists in unacceptable behavior, a written warning will be issued and given to the parent. The director will speak with the child and their parents. The parent will be required to sign the written warning and will be required to pick up their child

After receiving two written warnings, the child is dropped from camp and is not permitted to participate in Pelican Summer Fun in the future. NO refunds will be given. Please review these rules with your child prior to the first day of Pelican Summer Fun and return the signed guidelines to the director. Thank you for your cooperation. We hope to have a great summer!
